PUBLIC COMMENTS:

Resident of Justice and member of the Economic Planning Board, David Shipyor asked for a discussion regarding an agenda item on the agenda for this evening regarding two resolutions related to the property on 88th ave. He asked why the project did not come before the Economic Planning Board prior to being presented at the Committee meeting of September 19, 2018.

Trustee Kuban asked the chair for permission to respond and it was granted. COMMITTEE REPORTS:

PUBLIC SAFETY AND HUMAN SERVICES: Trustee Rick Symonds

Trustee Symonds started his report by inviting Chief McDermott to the front to offer a presentation and video for two of our officers that went above and beyond their duties to help a resident in distress. The video was a replay of the officers body camera that showed an incident from the fire that had occurred at the Sunset Lakes apartment complex on 8-04-2018. Corporal DeBella and Officer Wyatt were on scene going door to door in an effort to evacuate the building. A physically impaired resident needed help getting out of the burning building. Our officers stayed with the resident and helped the fire department get the resident to safety. Chief McDermott and Mayor Wasowicz offered praise and thanks for their service.

DISCUSSION: Trustee Oszakiewski call for discussion and reads the following statement:

Henry Oszakiewski Village of Justice Trustee September 24, 2018

Circumventing the established economic development process is NOT recommended. You have a copy at your desk. On page _6 of the document written and published in 2016, the economic development board has an opportunity to review a developer's plans at a meeting scheduled by them, so that they and ANY Justice resident or business owner who attends, especially those property owners within 250 feet of the development site, could offer village trustees their feedback and recommendations on the development site. We should not be voting on any motion today before our residents have had a chance themselves to listen to the proposal. Our residents have a voice in decisions through us and that should not be circumvented for any reason, including to expedite the review process for the developer. In particular and in this case, we need to hear from the Asbury Woods, Deer Path, Lost 17, Cork Highlands, and the Justice Industrial Park property owners.

We also need to vet the developer by asking for key references, researching those references and discussing our findings in a public forum.

Finally, we also need to speak with our neighbors in Bridgeview, specifically Mayor Steve Landek and their Board of Trustees, to see if another soccer sports dome in Justice would really benefit the region, knowing they already have a sports dome in Bridgeview operating there for many years.

This motion needs to be withdrawn and the steps to hear our residents, business owner's and Mayor Landek's feedback scheduled. Let's not only talk about putting residents first, just do it Where selfish ambition exists, there is disorder and every foul practice

Mayor Wasowicz responded to the board that the presentation from the committee meeting was not a full presentation; just an overview of what they wanted to do. He also explained to Henry that his comment about Bridgeview was "preposterous." Henry must have wasted his time on the Economic Planning Committee. He went on to say the resolutions are meaningless at this time.

Rick Symonds added the resolution to place the ad had nothing to do with the project being voted on in the next item

"To explain, the Resolution states, "Notwithstanding anything in this resolution expressed or implied to contrary, neither the Developer nor any other party is entitled to rely on this resolution as a commitment on behalf of the Village to establish the to enter into a redevelopment agreement, to convey the subject property, or for the approval of the Project, nor shall the same be deemed to obligate or require the Village to expend or loan monies, or to issue notes, bonds, or any other form of security, and the Village hereby reserves the right, in its sole discretion, to refuse to take any of the aforementioned action without cause and without notice, and in such event the Village shall not be subject to suit or liability for damages of any nature, whether or not Developer or such other party has incurred such costs, expenses, liability or damages in reliance on this resolution or the statements made herein."

President Wasowicz called for a second for the motion on the floor

Motion FAILS for lack of a second

Mayor Wasowicz and Trustee added commentary about the lack of a second. Trustee Kuban added, "to let you know what happened here is this was to say to the developer yes Justice is interested in your project which was not seconded." Trustee Rusch added that village interest in a "dome" may detract other developers from coming forward with a different plan.

Trustee Symonds brought up a discussion related to the Create Project and the Railroad fly over project. He had several comments related to the public hearing that was hosted in Summit. Matt explained that the entire project plan is on display at the Justice Public Library and comments are being taken for the next couple of weeks. Trustee Symonds is concerned about the bike path project that is also going on in that area and wants to ensure everyone is aware of both projects. The Mayor, Matt and Trustee Kuban explained that they spoke with the individuals from the Create Project at the public hearing and they are aware of and have talked with CMAP about the bike trail, and the need for drainage and access. They suggested possibly a new culvert.

PUBLIC COMMENTS:

Carlos Juarez, owner of CLJ Automotive at 9012 W. 79th Street, Justice, prepared a folder for each of the elected officials and handed one out to each. The folder contained a

letter of complaint about the mayor and a series of questions and pictures concerning an illegal automotive repair business at a Justice residential home at 7531 Cronin Ave, Justice. Carlos also provided parts of a string of e-mails that provided information about the complaint as well as personal communication based on what he called "an illegal business across the street from the mayor's home."

There was a discussion between the mayor, the business owner, our building commissioner and deputy code enforcement inspector. Carlos reviewed the details of his complaint and the timeline of activities that he has recorded. He also provided pictures of cars. *Carlos* complained of continuous car repair operations at the resident's home on Cronin Ave. These complaints were dated from June 2018 to current. A home automotive repair facility violates code. The mayor also stated he has known these neighbors at 7531 Cronin Ave for many years, having them both living in Chicago on 59th Street as neighbors. The mayor continued that in position as mayor, he should be able to do favors for friends, as why would helping a friend be a problem? Carlos' questions were not answered by the mayor. His response was that he saw nothing wrong of it. The mayor called the automotive work done at the 7531 Cronin Ave residence as a "hobby". Hank asked the mayor what he planned on doing to resolve the ordinance infraction; with no answer given at the meeting.
