The **Building Department** would like to remind our residents to make sure that your **Address** is posted on your house and is visible from the street with address numbers and letters that are a minimum of four inches high, and of a different color than the building on which they are placed. Address numbers must be on the building along with being on your mailbox so that emergency responders such as police, fire department and ambulances can locate your home. Ongoing and upcoming projects include; New culverts and tiles to the 71st Street Ditch from Cork Ave., Drainage and swale upgrades on Cork and Blackstone Avenues, A new storm sewer near 73rd Pl., A storm sewer and ditches at 75th and Oak Grove, Installation of surface drains on 84th Ct..

Chipping will continue through the Fall and grass cutting will be underway soon. Street repairs will be starting that include street patching on Blackstone Ave. and Indian Ln. A schedule of other streets will follow as well as filling potholes throughout the village. S.W.A.P crews will continue to aid Public Works in the maintenance of ditches in the village throughout the Summer.

Trustee Michael Murray : Public Safety Committee



I currently serve as Chairman of the Village's Public Safety Committee, along with committee member, Trustee Jeff Kranig. This committee oversees all issues regarding the Police Dept., Emergency Management Agency, and Village fire safety issues.

During the past few months we

have started working on a few new projects with the Police Department. The Village has entered into an agreement to handle dispatching for the Roberts Park Fire Protection District. This benefits the village and the fire protection district by reducing cost and putting people who are more familiar with the area in charge of getting the quickest emergency response when needed.

Recently, Mayor Wasowicz, Trustee Kranig and I worked with Congressman Lipinski. The Village awarded a \$100,000 Homeland Security Grant to update radios used by patrol officers use on a daily basis. We just took delivery of two new squad cars and have applied for a grant to get a third squad.

In the last two months, two residential fires occurred where the residents had to be temporarily relocated. I want to Congratulate the efforts of Cpl. Ronald Brenza and Patrol officer Carmine Scardine and Lt. Consolino from the Cook County Sheriffs Police who risked their lives, and rescued a village resident from a fire before the fire service arrived to put out the fire. For their efforts these three gentleman were awarded the Justice Police Department's Life Saving Award.
