Public Notice

Notice is hereby given that a Public Hearing (the “Hearing”) will be held by the Zoning and Planning Commission of the Village of Justice (the “Village”) on Thursday, the 30th day of December, 2009, at 7:00 P.M. at the Justice Administration Building, 7800 S. Archer, Justice, IL 60458.

The Hearing will concern the Village’s petition (#2009-01, hereinafter the “Petition”) for an amendment to the Village’s Comprehensive Plan by adopting Phase III thereof, which would include an amendment to the Village’s zoning map that would re-zone certain properties described below from their current zoning classification to a B-1 classification under the Village’s Zoning Ordinance.

The properties to be affected by the adoption of Phase III of the Village’s Comprehensive Plan and by the proposed zoning map amendment (the “Properties”) are generally situated as follows:

The property adjacent to the East side of 88th (Cork) Avenue between 83rd Street and 87th Street currently Zoned other than B-1; the property adjacent to the North Side of 87th Street, between 88th (Cork) Avenue & 86th Ave., and property adjacent to the North Side of 87th Street between Roberts Road (80th Avenue) & the East Village of Justice Boundary (Eastern North/South Lot Line of Property between 78th Court & 78th Avenue, perpendicular to 87th Street.
