General Information

Administration Office: 708.458.2520

Mayor, Village Clerk, & Finance Office:

Services including the sale of Animal Licenses; Collection of Sewer & Refuse Bills; Garage Sale Permits; Notary Services; Passport Services; sale of Postage Stamps; Vehicle Stickers; yard waste and garbage matters, and the rental of the All-Purpose Room.

Sewer and Refuse Billing: Bills are computed every two months (odd months). Pay your bill in person, by mail, or for added convenience, pay online using E-pay or the use the IVR automatic phone payment system. After hours, use the drop box outside the main office. All major credit cards are accepted.

Senior Discounts: Discounted rates on Sewer & Refuse Bills and Village Vehicle Stickers are available at age 62 and over. To apply please contact the Finance Office.

Village Vehicle Stickers are required!

In compliance with Village Code Chap. 6, Art. II, Sec. 6-22, all motor vehicles are required to display a municipal vehicle sticker within thirty (30) days of moving into the village or obtaining a vehicle. Annually, vehicle stickers are sold in May and June. Vehicle registration is required to purchase. After June 30th, vehicle sticker applications must be accompanied by a home purchase agreement/signed lease or bill of sale for the vehicle, in order to purchase the sticker at the regular rate. Vehicle stickers can be purchased in the police department after normal business hours.

Pet Registration

In compliance with Village Code Chap. 7, Div., 2, Sec. 7-121, annual registration is required for all cats and dogs in the village. Proof of rabies vaccination must be presented.

Passport Applications are available in the Finance Office. Passport processing available Monday-Friday from 8:30AM to 3:30PM.

***Sec. 10-28 (e). Parking:** *The operator of a vehicle shall not park such vehicle on any street, highway, alley, public way or parkway between the hours of two o'clock (2:00) A.M. and six o'clock (6:00) A.M. except Sundays and holidays.*

***Sec. 10-28 (c). Parking:** *Regardless of such posting, no parking shall be allowed on any public street or property within twenty four (24) hours after a snowfall of one inch (1") or more has occurred.*
